Federal solid and hazardous waste regulations (i.e., the RCRA requirements) apply to solar panels when they are discarded. When a solar panel reaches the end of its usable life or is otherwise discarded, it becomes solid waste. Solid waste is regulated federally under RCRA Subtitle D and through state and local government programs.

The landfill is a non-hazardous solid waste acceptance facility that accepts residential and commercial solid waste (household refuse and waste from businesses, stores, and offices), bulky waste (household appliances and white goods), institutional (non-hazardous waste from schools, hospitals), asbestos, incinerator ash, land clearing debris ...
