

The former de facto foreign minister called the US State Department, the US Agency for International Development (USAID), and the European Union "subjects of aggressive isolation of Abkhazia." Since the start of the intensified confrontation between Russia and the West in 2014 and the weakened ruble as a result of sanctions, counter-sanctions, and economic crisis, Abkhazia has bolstered its trade with the West. Turkey is now Abkhazia's second most important trading partner, taking in roughly one-third of Abkhazia's exports.

Despite the fact that Abkhazia has been under an embargo on all trade and for-ign economic activities by Georgia, economic and trade ties between Turkey and Abkhazia have intensified rapidly during the past few years.<sup>3</sup> Turkish investments have increased in Abkhazia, unofficial trade is reaching higher marks every year,
