American Airlines Cargo has made a change to the acceptance and carriage of Class 9, UN3480, Lithium ion batteries: We will no longer accept for carriage UN3480 Section IA, IB and Section II lithium ion batteries, Packing Instructions 965. We do accept UN3481 or UN3091 lithium ion batteries packed with or contained in equipment.

Each spare battery is individually protected in accordance with our lithium battery acceptance policy. For a lithium metal battery, lithium content cannot be more than 2 grams per battery. For lithium-ion batteries, a maximum of 2, not exceeding 160 Wh each, are allowed in carry-on ...

Note 1: For lithium batteries, the lithium metal content should not exceed 2 g and for lithium-ion batteries the rated capacity in watt-hours should not exceed 100 Wh. American Airlines has specific rules for these items: Spare batteries: You can carry up to two spare batteries in your carry-on bag. Each battery must be individually protected. Lithium metal batteries: The lithium content in each battery cannot be more than 2 grams.

Lithium-Ion Batteries for Portable Electronic Devices Please Note: Lithium batteries recalled by the manufacturer/vendor must not be carried on board or packed in baggage. Battery-powered devices recalled because of lithium battery safety concerns also must not be carried on board or packed in baggage.

Lithium-ion batteries: You can carry a maximum of two lithium-ion batteries, with each battery not exceeding 160 watt-hours (Wh). You may need airline approval for these. Personal transportation devices: Lithium-ion battery-powered personal transportation devices like hoverboards or scooters are not allowed on board, as carry-on or checked baggage.

American Airlines Cargo no longer accepts shipments of UN3480 Sections IA, IB & II Effective date: April 15, 2015 This does not impact the shipment of UN3481 lithium ion batteries packed with or contained in equipment, or UN3091 lithium metal batteries packed with or ...

Lithium ion batteries must be removed from this type of mobility device and battery terminals protected from short circuit. The battery must be protected from damage (e.g. by placing each battery in a protective pouch). The lithium ion batteries must be carried in carry-on baggage only. The passenger must advise the airline of the battery location.

American Airlines: All lithium batteries and devices with them installed can only be in carry-on luggage. Delta: You can put a device with an installed lithium battery into your checked luggage if it is fully powered off. Spare lithium batteries are not allowed in checked luggage, however.

There IS a drone policy for American Airlines; You CANNOT check drones and batteries, they must be in carry-on luggage/bags; Bring no more than 2 individually stored 160Wh (or less) batteries ...
