



# Anti dumping solar panels

Today, Secretary of Commerce Gina Raimondo released the below statement following President Biden's emergency declaration regarding the temporary duty-free importation of solar cells and modules from Southeast Asia to avoid disruptions to the electric power system:

The United States has had anti-dumping duties in place for a decade on Chinese-made solar products after a Commerce probe found Chinese companies were receiving unfair government subsidies that ...

Jinko and Risen solar panels are subject to anti-dumping duties of 32.69% (although Jinko panels appear to be being blocked by US Customs due to forced labor concerns). Anti-dumping duties of 23.17% are being collected on panels from JA Solar, Suntech, LONGi and six other Chinese manufacturers.

The executive said it had no plans to renew the long-standing measures, which expire at midnight on Monday. The decision was welcomed by some but condemned by others, including EU ProSun, the grouping of EU producers that launched the initial complaint about solar panels from China back in 2012 and wanted a further extension of measures.

The US switched its China and Taiwan anti-dumping duties to uniform tariffs on all imports of solar panels in January 2018. This research uses an Equilibrium Displacement Model (EDM) to determine the relative effects of these two tariffs on domestic consumer and producer welfare, employment, government revenue, and environmental costs.
