While there are no grants solely for solar panels, it is possible to get funding when taking a combined package of both solar panels and a heat pump. Grants for solar panels will help households with low energy efficiency homes who are considered likely to face financial difficulties heating their homes.

No typical residential solar energy grants are given directly at the federal level; instead, the departments provide grants to low-income and rural areas alongside farms, tribes, schools, and nonprofit organizations.

Energy Company Obligation (ECO4) Scheme (government-backed) ECO4 is a government-backed scheme worth £4 billion designed to improve the energy efficiency of the least energy efficient households in the UK.
