



Arizona renewable energy property tax incentive program

Tax credits and rebates are available to property owners who upgrade or maintain renewable energy sources. One such program is Arizona's Energy Equipment Property Tax Exemption, under which renewable electric generation, including solar thermal electric, photovoltaics, landfill gas, wind and biomass is not considered by the state to add. This credit provides a state tax deduction equal to 25% of your total solar energy system cost, up to a maximum of \$1,000. Homeowners file for the credit along with their personal state taxes. after December 31, 2016, to a period of 10 years. Kansas statute exempts renewable energy equipment from property taxes if an application for an exemption is filed for the property on or before December 31, 2016.

The renewable energy production tax credit is for installations created for the purpose of selling the energy; the commercial and industrial solar credit is for purchasing and installing solar energy

Some states created new, statewide statutory incentives or exemptions specific to renewable energy facilities, while other states created renewable energy incentive or exemption regimes that are at the option of the local jurisdictions. Other states have, instead, added renewable energy facilities into existing economic incentive programs.

H.B. 3354 of 2021 established a property tax exemption for renewable energy systems with a rated capacity of not more than 20 kW-AC.
