The 8.6% sales tax rate in Phoenix consists of 5.6% Arizona state sales tax, 0.7% Maricopa County sales tax and 2.3% Phoenix tax. There is no applicable special tax. You can print a 8.6% sales tax table here. For tax rates in other cities, see Arizona sales taxes by city and county.

What is the city and county tax rate? The city's tax rate is 2.4%; the combined rate (including county tax) is 2.9%. The state of Arizona does not impose a transaction privilege tax on the rental of commercial property. When are tax payments due? Tax returns and payments are due on the 20th day of the month following the reporting period.

The total sales tax rate in Phoenix comprises the Arizona state tax, and the sales tax for Maricopa County. The city also imposes an additional sales tax of 2.30%. The table below provides a breakdown of the sales tax rate by jurisdiction.

The Phoenix, Arizona sales tax is 8.60%, consisting of 5.60% Arizona state sales tax and 3.00% Phoenix local sales taxes. The local sales tax consists of a 0.70% county sales tax and a 2.30% city sales tax.. The Phoenix Sales Tax is collected by the merchant on all qualifying sales made within Phoenix; Groceries are exempt from the Phoenix and Arizona state sales taxes

Including these local taxes, the lowest sales tax rate in Arizona is 5.6% in seventeen cities, including Fort Mohave and Golden Valley, and the highest sales tax is 11.7% in two cities, including Florence and Casa Grande.
