Brad Carothers, who runs New Slate, lives in Knox County and raises Katahdin sheep. When a letter came from Open Road Renewables about the Frasier Solar project, he reached out to the company. "One of the main issues new and emerging farmers face is access to land," Carothers said. "We're a first-generation business.

Knox County generates 1,938,512.59 megawatt hours of electricity from the use of coal, ranking Knox County 8th in the state out of 92 counties. Residents of Knox County are paying, on average, 23.82% less per kilowatt hour at home than the national average, at 12.32 cents per kilowatt hour compared to 16.17 cents per kilowatt hour.
