Instead, individual electricity retailers assign a value to exported solar power as they see fit. Some retailers offer more than others, and some retailers offer nothing.

To be eligible for AGL's solar feed-in-tariff rate, the inverter capacity of your solar system must not exceed, or must be export limited to, 10kW (for NSW), 10kVa per phase (for SA), 30 kW (for Qld), or 100kW (VIC)

and you must not be receiving a feed-in tariff under any government scheme.
