In April 2022, the Minnesota AG filed a lawsuit against Utah-based solar companies, lenders and company executives, for telling "consumers they were automatically eligible for tax credits when they weren"t . . . [and] [w]hen consumers tried to get out of these contracts, the companies threatened them with lawsuits and exorbitant termination fees."

These tactics may include persistent calls, scare tactics, door-to-door visits, or making unfounded claims about solar benefits. Companies employing such methods prioritize sales over delivering quality service. These are the red flags to identify solar panel companies to avoid scams.

When the tax credit falls short of their expectations, they may hold the solar company responsible for the misleading information. Example: A homeowner was advised by a sales rep from a ...

This position is also now being adopted by the Court of Appeal, in its recent decision in Comag Steel and Construction Company Limited v. Enugu Electricity Distribution Company Plc (Unreported Appeal No: CA/E/100/2020). In this case, the complaint at the High Court bothered on unreasonable electricity billing, illegal disconnection.

If you're dissatisfied with the actions of your insurance company or insurance agent, you can file a complaint with your state department of insurance (DOI). Delays, denials, and unsatisfactory settlements are among some of the most common reasons for consumers to file complaints. To file a claim, there are specific steps you'll need to take:

Where to file a complaint against a federal agency. File a complaint by contacting the agency first. Find the agency using this alphabetical government agency directory to get contact information for the agency program you want to complain about.; If you cannot solve the issue after contacting the program, contact the agency's Office of the Inspector General (OIG).

Once you have your evidence and legal representation in place, you can proceed with filing a lawsuit against your solar company. The specifics of this process will vary depending on your location and the local legal



procedures. So, what can you expect if you decide to move forward with a lawsuit against your solar company?

Public Service Law Section 71 - Addresses complaints related to the quality and price of gas and electricity..
