Notify your local police. Place your mail on hold if needed, until you repair or replace your box. Contact your Local Post Office if you need further assistance. Notify your local police. Just like with other items listed above, make sure you have the serial number for the item that may have been stolen, and file a police report before hunting for the item. In most cases, you should be able to get your things back without having to pay the pawnbroker, but state law may differ, so check local regulations.

For Third-Party Seller Items: Go to Your Orders and find the item. Select "Contact the seller"; Explain the package appears stolen and ask if they can replace or refund. If no response in 24 hours, file an A-to-z Guarantee claim on Amazon. For Amazon Items: Go to Your Orders and select "Report a problem"; under the item.

You have the option of deducting the theft by increasing the cost of goods sold when you complete your Schedule C. Simply deduct the value of the stolen items from your closing inventory. Another option you have if you think your package was actually stolen is to file a police report with your local authorities. There likely won't be much they can do, especially if there are...

In case you suffer a theft (in a Hotel, station, restaurant, etc.), or if you lose a precious item (credit/debit card, wallet, expensive watch, etc.), or similar, while in Italy, you will need to file a theft/loss report (denuncia di furto/smarrimento) with an Italian authority (e.g. Polizia di Stato or Carabinieri).). Technically, you can file a theft/loss report in English.

Here are some items to consider before filing an insurance claim: Some insurance policies require you to file a police report in order for insurance to cover the stolen items. Determine whether or not the loss is large enough to significantly affect your business. Your determination can affect how the inventory shrinkage is recorded. If the loss is relatively small, it should be recorded as part of the cost of goods sold. However, a larger loss will be reported as a separate line on the income statement.
