According to the Solar Energy Industries Association, Michigan had enough solar capacity to power 83,045 homes in the first quarter of 2021 -- out of 4.6 million homes in the state. That's just 1.8 percent of Michiganders' homes. Solar companies numbered 188 in Michigan, employing 3,379 people out of 231,000 jobs nationwide.

The EPA requires that the Solar for All program operates within a five-year performance period, during which all allocated funds must be utilized. The State anticipates taking full advantage of the one-year planning period

According to Climate Power, through funding from the IRA, Michigan has introduced 45 new clean energy projects, ranging from solar and EVs to hydrogen and batteries, the most across any state in the nation. The IRA has spurred \$21.52 billion in investments in Michigan, creating or moving forward more than 20,000 clean energy jobs across the state.

The biggest energy policy event in the Midwest this year came on Nov. 28 when Michigan Gov. Gretchen Whitmer signed a package of bills into law that will quadruple Michigan's renewable energy ...

In the United States, there are no federal solar access laws in 2023. Instead, solar power access laws may be controlled at the state, county, or city level, depending on your location. ... There are two main pieces: Michigan will require all energy produced in the state to be "clean" by 2040, and to help reach that goal, the state government will take approval control of large solar, wind and energy storage projects away from local governments.
