Currently, Ohio has 1.6 GW of solar, wind, and storage capacity. There is over 3.6 GW of additional planned clean energy capacity in the works in Ohio, which will more than double the amount of clean energy available on the state's grid and power more than 402,000 additional homes. In tandem with the grant program, the U.S. Department of Energy also is announcing funding for the \$4.5 million Energy CLASS Prize. The Energy CLASS Prize will provide \$100,000 in awards to as many as 25 schools and districts for the purpose of staffing and training energy management positions.

The Energy Efficiency and Conservation Block Grant (EECBG) Program is a \$550 million grant program funded through the Bipartisan Infrastructure Law. It is designed to assist states, local governments, and Tribes in implementing strategies to reduce energy use, to reduce fossil fuel emissions, and to improve energy efficiency.

Ohio Governor Mike DeWine and the Ohio Department of Development have announced an additional \$5.4 million in grants to support energy efficiency projects in five counties across the state. The first round of awards, announced on May 8, provided a total of \$3.1 million to four organizations in three counties.

The Office of Energy Efficiency and Renewable Energy is the largest investor in clean energy technology development in the U.S. Government. During the Biden Administration, EERE has published FOAs totaling over \$3.8 billion and has selected promising proposals to receive more than \$884 million in awards.
