Given the high volume of waste, closing a fully loaded landfill site would cost about 20 million Malaysian Ringgit (about 4.7 million USD). Therefore, the government is considering expanding waste-to-energy (WTE) facilities. Nga Kor Ming pointed out that China has 700 waste-to-energy plants and Singapore has 5. In comparison, Malaysia has only 1.
