



# Solar photovoltaic standard offer program oncor

Some retail electric providers offer buy-back plans for surplus generation sent to the grid. Customers should compare plans carefully to maximize their savings on electric usage. Oncor has a solar photovoltaic program that helps customers find service providers, and offers incentives that may offset initial costs.

Incentives are limited to 20% of the program budget (incentive cap) for each Service Provider (in combination with its affiliates). Oncor may raise the incentive cap based on program performance. \*Oncor reserves the right to increase or decrease the actual incentive budget of the program during the program year as needed to achieve Energy ...

Oncor offers incentives for both residential and commercial customers in their service territory through the Oncor Solar PV Standard Offer Program. In deregulated areas (Oncor service territory), customers can choose a retail electric provider that buys back excess power produced during the billing period, known as Renewable Energy Buy-Back Programs.



## **Solar photovoltaic standard offer program oncor**

Unlike the HEE program, which is available for renters, the solar PV program only applies for Oncor customers who own the home where they live. This benefit can be combined with the Solar Investment Tax Credit (ITC), which was increased to 30% and extended for 10 years by the Inflation Reduction Act (August 2022).

Oncor's Solar Photovoltaic Residential Program. Oncor homeowners who plan to install solar panels can reduce their costs with the Solar Photovoltaic Standard Offer Program (SPVSOP), increasing the return on investment. If the solar power system meets the following requirements, it is eligible: Generation capacity between 3 kW DC and 15 kW DC.

**COMMERCIAL STANDARD OFFER PROGRAM.** ... This includes any entity that installs eligible solar photovoltaic systems at a customer site with residential or commercial electricity distribution from Oncor. ... This program manual is a guide to HEE SOP requirements and processes for our network of participating service providers. This program complies with the standard offer program requirements published by the Public Utility Commission of Texas (PUCT). This program manual is intended to inform service providers of the program requirements and processes.

Oncor provides incentives to service providers and self-sponsors who install eligible energy efficiency measures at facilities serviced by Oncor through their Commercial Standard Offer Program (CSOP). Independent companies/contractors are eligible to participate. The program is divided into deemed projects and measurement & verification projects.
