Lithium metal batteries will use labels with one of the following UN numbers: UN3090 UN3091; If you're shipping lithium metal batteries as a standalone (no other items in the package), use a battery label with UN3090. If you're shipping lithium metal batteries contained in or packed with equipment, use a battery label with UN3091.

This article includes updates effective March 12, 2021. Shipping Regulations When shipping lithium batteries, businesses must comply with U.S. Department of Transportation (DOT) standards and Pipeline and Hazardous Materials Safety Administration (PHMSA) standards for preparing shipments that contain lithium batteries.

Lithium batteries are mailable within certain guidelines; see domestic and international shipping restrictions. HAZMAT Search Tool Many common household products contain hazardous materials (HAZMAT, or dangerous goods [DG] when shipped internationally).

Lithium battery consignment means one or more mailpieces containing lithium batteries, entered into USPS networks by one mailer or mail service provider within a single mailing or retail transaction, or included in the same manifest or shipping services file, and intended for delivery to a single consignee at a single destination

If you are shipping lithium batteries, USPS requires them to be shipped in specific packaging designed to protect against short circuits and accidental activation. These packages are marked with appropriate labels to notify the carrier and handling personnel about the potential hazards associated with lithium batteries.

Publications Publication 52 Revision: New Mailing Standards for Lithium Batteries . Effective March 2, 2015, the Postal Service(TM) will revise Publication 52, Hazardous, Restricted, and Perishable Mail, in various sections to provide new standards for the mailing of lithium batteries.. These revisions were initially announced via a notice in the Federal Register on January 26, ...

If your laptop has a lithium battery, you have to use a special label that indicates that your package contains lithium batteries. You can get this label from a postal store or online. The label should have the words "Lithium Battery" and "UN 3481" on it, ...

UPS will update this guidance document as quickly as possible. Lithium battery shippers must stay abreast of changes. UN38.3 test summary documents must be made available upon request

Lithium batteries are dangerous goods, and all of the regulatory requirements must be complied with, as set out in the Lithium Battery Shipping Regulations. In the United States, failure to comply with these regulations can result in a civil penalty of up to \$27,000 per offence (LBSR 1.3).

For shipping lithium batteries with USPS overseas, you can ship a maximum of 4 cells or 2 batteries that are installed in the new or certified refurbished equipment or device it operates, without any lithium battery markings. However, individual batteries are prohibited from USPS international shipping.

The Postal Service announced these revisions via a Federal Register notice titled "Revision to Mailing Standards for Lithium Batteries," which was published on July 26, 2017 (82 FR 34712-34715).

USPS Packaging Instruction 8B Nonspillable Wet Battery. A nonspillable wet battery containing liquid electrolyte is prohibited from mailing unless the battery casing is completely sealed to prevent the liquid corrosive from spilling during handling, as allowed in 348. Nonspillable batteries with UN2800 are prohibited in international mail, but they may be sent as domestic mail via air ...

Also, while I was just at the post office, I asked about the air-shipping restrictions for items with batteries, and I specifically asked if it was just for Lithium-ion batteries, and she said that this restriction applies for any type of battery.
